

Spot the Ball Terms and Conditions

By entering the Competition, you agree to be bound by these terms and conditions (these Terms and Conditions).

Participation in the Competition

1. Residents of the United Kingdom aged 18 or over only, except employees and agents of My Club Europe PLC and anyone otherwise connected with the operation or fulfilment of the Competition (including third party promotional partners) and their respective associated, affiliated, or subsidiary companies, and the immediate families and household members of all such employees and agents.
2. The Competition consists of a monthly competition starting at 00.01hrs on the 1st day of every month and ending at 11.59hrs on the last day of every month.

Any entries for a Competition received outside each Competition Period will be void, except that postal entries will be accepted up to three working days after the expiry of the relevant Competition Period.
